1.The government promulgated Protocol No. 42/2023/ND-CP on June 29, 2023 to adjust pensions, social insurance allowances and monthly allowances



From July 01, 2023, the adjustments are as follows

Pensions, social insurance allowances and monthly allowances for June 2023 of the objects stipulated in the first paragraph of Article 1 of this agreement have been increased by 12.5%, and pensions have been adjusted in accordance with the government's agreement No. 108/2021/ND-CP dated December 7, 2021, social security allowance and monthly allowance.

Pensions, social security allowances and monthly allowances for June 2023 subject to the provisions of Article 1, Clause 1 of this Act have been increased by 20.8%, and pensions have not been adjusted according to the Government's Agreement No. 108/2021/ND-CP dated December 7, 2021, social security allowance and monthly allowance.

From July 1, 2023, those who enjoy the pension, social insurance allowance or monthly allowance stipulated in the second paragraph of Article 1 of this agreement, after adjusting according to the provisions of the first paragraph of this article, if the benefit level is less than 3,000,000 VND / month, the adjustment amount will be increased as follows: If the benefit amount is less than 2,700,000 VND/person/month, an increase of 300,000 VND/person/month.

Pensions, social insurance allowances, and monthly allowances adjusted in accordance with the provisions of this article shall be used as the calculation basis for the adjustment of pensions, social insurance allowances, and monthly allowances at the time of adjustment.

This agreement will come into force on August 14, 2023.



2. Circular No. 06/2023/TT-BLDTBXH dated June 29, 2023 of the Ministry of Labor, Invalids and Social Affairs directing the adjustment of pensions, social insurance benefits and monthly allowances



a) From July 1, 2023, the pensions, social insurance allowances and monthly allowances of the objects stipulated in the first paragraph of Article 1 of this notice are adjusted as follows:

Pensions, social insurance allowances and monthly allowances for June 2023 of the objects stipulated in the first paragraph of Article 1 of this agreement have been increased by 12.5%, and pensions have been adjusted in accordance with the government's agreement No. 108/2021/ND-CP dated December 7, 2021, social security allowance and monthly allowance.

- b) Pensions, social security allowances and monthly allowances for June 2023 subject to the provisions of Article 1, Clause 1 of this Act have been increased by 20.8%, and pensions have not been adjusted according to the Government's Agreement No. 108/2021/ND-CP dated December 7, 2021, social security allowance and monthly allowance.
- a) For those whose pension, social insurance allowance or monthly allowance is less than 2,700,000 VND/month, the pension, social insurance allowance or monthly allowance shall be adjusted according to Article 2, Clause 1 of this Notice, and an increase of 300,000 VND/month shall be added.
- b) For those whose pension, social insurance allowance or monthly allowance is from 2,700,000 VND/month to less than 3,000,000 VND/month, the pension, social insurance allowance or monthly allowance is adjusted to 3,000,000 VND/month

This agreement will come into force on August 14, 2023.



3. Circular No. 24/2023/TT-BCA dated July 1, 2023 of the Ministry of Public Security, regulating the issuance and withdrawal of motor vehicle registration plates



According to Article 6, Paragraph 4 of Circular No. 24/2023/TT-BCA, from August 15, 2023, car owners must do the following when selling or giving away a vehicle:

The vehicle owner must keep the vehicle registration certificate and number plate (which shall not be handed over to an organization or individual who accepts the transfer from the owner), and submit the vehicle registration certificate and number plate to the vehicle registration agency for recovery procedures.

If the ownership of the vehicle is transferred together with the license plate of the winning vehicle during the auction, the owner shall submit the vehicle registration certificate to the vehicle registration agency for recovery procedures.

Within 30 days from the date of preparing the vehicle ownership transfer document, the vehicle owner must go through the recovery procedures.

If the above-mentioned time limit is exceeded, the vehicle owner fails to go through the recovery procedures or hand over the vehicle registration certificate and number plate to the organization or individual who accepts the vehicle to go through the recovery procedures, the vehicle registration authority shall make a punishment decision before handling the vehicle and the vehicle owner fails to go through the recovery procedures in accordance with the regulations.

If the owner of the vehicle fails to go through the recovery procedures after the transfer, he shall be held accountable for the illegal behavior of the vehicle in accordance with the law.

After the vehicle owner completes the take-back procedures, the unit or individual accepting the vehicle shall go through the vehicle ownership transfer registration procedures in accordance with regulations.

This notice will come into effect on August 15, 2023.
